A Challenge To Southern Governors

The governors of 16 Southern states were urged in their recent conference to aid General Eisenhower in solving the racial problems of the nation. The proposal was made by Neville G. Parson, the chairman of the Texas "Good Neighbor Commission."

That a vast change in attitude toward the racial problem is due is indicated by the steady advances made toward the elimination of segregation and the wider political participation of Southern Negroes.

Several Northern cities, plagued by racial problems, have established "Good Neighbor Commissions" or similar bodies; among them, Cincinnati, Chicago and Detroit. These semi-official groups, composed of both whites and Negroes, attempt to iron out the frictions and differences arising between the races.

Such a system would, of course, eliminate the necessity to enact a compulsory employment program - the emphasis being on friendly, rather than legal, settlement of racial differences.

"States' Rights" should certainly bring to mind "States' Responsibilities" - and it is the responsibility of our Southern states to adjust its affairs justly and reasonably.

Nashville Fights Jimcrow Golf Link

NASHVILLE, Tenn. - The Nashville City Council Thursday authorized the issuance of \$50,000 in general obligation bonds, \$40,000 of which will go for the installation of a controversial golf course for Nashville Negroes.

The bill to establish the segregated golf course was introduced by Councilman Robert E. Lobb, a Nashville Negro attorney.

Members of the park board of the city, against whom the federal suit is filed, are Edwin Crutcher, chairman; Dr. C. M. Sarant, Newark Chesel, and R. N. Collier. The fifth member of the park commission, G. A. Crute, resigned shortly before the suit was filed. He has not been replaced. None of the board members are Negroes.

Let by the Nashville Branch of the NAACP and an organization of local Negro golfers, the entire Negro community was mobilized against the effort for segregated golf facilities when there are already three non-segregated golf courses. Atty. E. B. J. Campbell is president of the local Branch.

A suit now in federal court, filed by Atty. Lobb on behalf of the Gold Association, seeks to enjoin the city park board from discriminating against Negroes on city-operated golf courses. NAACP Legal Counsel Thurgood Marshall is associated with Lobb in the case.

Ike, Taft Confer On Cabinet Appointments

NEW YORK - (By Kenneth A. Ungerman) - In General Eisenhower conferred with Republican Senate leader Robert A. Taft on possible cabinet appointments and "14 or 15 subjects" that will face the incoming Congress.

The Ohio Senator met with the President-elect at Ike's New York headquarters for nearly two hours. The two Republicans leaders, according to Taft, discussed legislation that may be required when the new administration takes over on January 20th.

Meanwhile, indications that Eisenhower's trip to Korea might be in the very near future appeared shortly after Senator Taft ended his meeting with Eisenhower. Major General Roger Ramo, director of Air Force Operations, paid an unscheduled visit on the President-elect, accompanied by Major General Wilton Parsons, one of Ike's close

# India's Truce Bid Gets U. S. Backing

## U. S. Agrees With Britain On Revised Plan Of India

UNITED NATIONS, N. Y. — (INS) — The United States in a dramatic move apparently inspired by President-elect Eisenhower yesterday suddenly agreed with Great Britain on a new plan to break the Korean prisoner deadlock and end the war.

The U. S. decision to drop its previous demands aimed against building a special address to the World Assembly and British Foreign Secretary Anthony Eden cancelled plans to return to England in order to hear him.

It is expected to become official Monday. Secretary of State Dean Acheson announced he will make a special address to the World Assembly and British Foreign Secretary Anthony Eden cancelled plans to return to England in order to hear him.

Eden took the floor of the UN Political Committee a short time after his luncheon conference with President-elect Eisenhower. Without a word he introduced a resolution originally drafted by the United States. Eden said:

"The UN resolution is a timely and constructive attempt to resolve this deadlock."

The UN resolution in general proposes the transfer of Korean war prisoners to a neutral area, where a four-corner commission of Sweden, Switzerland, Czechoslovakia and Poland—appointed over by an umpire—would supervise the disposition of the prisoners. At the end of 90 days, war prisoners still in the area or those refusing to go home would be referred to a proposed political conference on Korea slated to begin after an armistice.

The U. S. shift in position was touched off by Acheson's announcement before the UN Political Committee that India's recent compromise resolution may clear the way to peace in Korea.

His statement closely followed a private luncheon with General Eisenhower at the Commodore Hotel and it was authoritatively reported that the two had discussed Eden's projected talk.

Shortly after Eden completed his address, the U. S. spokesman said: "The divergence among the United States and the other Western powers has been healed."

"Eden's speech was helpful and constructive. It contained ideas about revision of the Indian plan which we want to examine." On the basis of his speech, it is possible to move toward complete agreement on the issue.

The Indian plan submitted by Delegate Krishna Menon is long, involved and far removed from any practicality.

Eden sought to dispel U. S. fears that new dead lock and disagreements would result over the disposal of prisoners by declaring that the India resolution covers the four basic principles insisted upon by the United States and Britain.

He cited these principles as follows: 1. All prisoners have the right to be released.

2. They have the right to be speedily repatriated.

3. It is the duty of the detaining power to provide transport facilities for the return of prisoners.

4. The detaining side has no right to use force in the disposition of war prisoners.

Soviet Foreign Minister Vishinsky said yesterday that he was not commenting on the Eden statement. An Iron Curtain source said, however, "It remains to be seen whether the India plan will come to anything. It is not in its major present form, or will be subjected to a barrage of amendments other than those proposed by Eden."

Sources close to the India delegation in Geneva said:

"High-priority matters under discussion include U. S. trip to Korea, the Neuzer and delicate foreign policy. The U. S. must pursue in a way made explosive by the constant menace of Communist aggression, and the 50 billion dollar program of spending for Korea with which the U. S. must cope."

# Ike Lauds Georgia Pastor For Attacking Race Bias

AUGUSTA, Ga. — (INS) — Gen. Eisenhower attended church and preached a sermon "choosing those people who use religion as a cloak for racial prejudice."

The preaching minister spoke to an overflow crowd in the small brick church that the Eisenhower family attended Sunday.

Dr. Deane of the Southland, Rev. Mack Mott Helzel, in his sermon struck out at the Ku Klux Klan and at "those men who seek to identify their opinions with God."

"At the close of the sermon, as he was leaving the church Gen. Eisenhower (standing next to an autographed Bible he had given him) said, "Thanks for those men in Tampa who identify themselves into believing God wanted them to drive out of town that they are doing his will."

# Widow Denies Putting Arsenic In Medicine

ATLANTA, GEORGIA. — (INS) — A six-month coroner's jury accused Mrs. Roberto Elder of poisoning her 15-year-old stepdaughter, Marie, with arsenic in the family case of arsenic and old insurance policies. The 43-year-old widow has already been accused of poisoning her husband and another step-daughter.

The jury held Mrs. Elder responsible for the death of Fannie Mae Elder, 15, who died last March. Her body was exhumed by court order on September 24.

In September, another coroner's jury found that the Rev. William M. Elder, 1238 East St. N. W., and his daughter, Annie Pearl Elder, died of arsenic poisoning administered by Mrs. Elder. Detective E. E. Helms said he was continuing an investigation into circumstances surrounding twelve other deaths, as far back as 1928.

"SPOILED" TWENTY centered testimony yesterday on the bottle of milk of magnesia which Detective J. E. Helms said was split with liberal portions of arsenic poisoning. Two Elder stepchildren testified that they saw Mrs. Elder give Fannie Mae a dose of milk of magnesia.

Detective Helms told the jury that Mrs. Elder took out insurance policies on Fannie Mae Elder on October 8 and October 10, 1951. Elder, he said, was the beneficiary. He also charged that Mrs. Elder was barred from paying back money which had been in her charge as treasurer of a fraternal organization.

POLICY BENEFICIARY The two policies on Fannie Mae totaled \$50, Helms said. He also introduced evidence that Mrs. Elder was beneficiary under the policy on Dorothy Elder, wife of Elder, Jr., and Annie Elder, the surviving children of the late Mr. Elder.

Mrs. June K. Jones, coroner testified that Fannie Mae died of arsenic poisoning. Dr. Herman D. Jones and the coroner's physician agreed with the findings. He said the hair and skin tissues of Fannie Mae contained 1.2 milligrams of pure arsenic, a sufficient amount to cause death.

The coronal death certificate of Fannie Mae listed pneumonia as the cause of death. The coroner's physician, however, testified that arsenic poisoning and pneumonia had caused her death.
